Consultation on admission arrangements for September 2026 entry

Norfolk County Council is currently asking people to comment on their proposed admission arrangements for the following academies:

The consultation period will run from Monday 9 December 2024 until Friday 31st January 2025; during this time parents and other key stakeholders are invited to give their views about the proposed admission arrangements.

Lowering of Published Admission Number Consultation:

Norfolk County Council is consulting on the published admission number for the above academies.

The following admission numbers are proposed:

- Kings Oak Infant Academy; 30 children for entry into reception (reduction from 60 to 30 children for entry into reception)
- Greyfriars Primary Academy; 30 children for entry into reception (proposed reduction from 37 children for entry into reception)
- Beeston Primary Academy; 10 children for entry into reception (proposed reduction from 12 children for entry into reception)
- St Germans Primary Academy; 10 children for entry into reception (proposed reduction from 15 children for entry into reception)
- Wimbotsham and Stow Primary Academy; 10 children for entry into reception (proposed reduction from 14 children for entry into reception)
- Magdalen Primary Academy; no proposed change
